## TOWN OF NAPLES BOARD MEETING

May 10, 2021

### **CALL TO ORDER:**

The Town of Naples Board Meeting was called to order at 6:00 p.m. by Town Chairman Dennis Olson presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755.

### **ROLL CALL:**

Board members present: Town Chairman, Dennis Olson, First Supervisor, Paul Accola, Second Supervisor, Brett Cole, Town Treasurer, Andy Goss, and Town Clerk, Jackie Dregney. Also present were Karon Olson, Neil Segerstrom, Kristen Peterson with Bug Tussle Wireless, Sue Iverson, Cathy Cole, and Bryan Wulff.

### **PUBLIC COMMENTS:**

Iverson asked when the Alleman Bridge would be started; Olson advised it has been pushed back to August 2021.

### **APPROVE MINUTES:**

Motion by Cole and seconded by Accola to approve the minutes from April 12, 2021. Motion carried.

Motion by Accola and seconded by Cole to approve the minutes from the 2020 Annual Meeting. Motion carried.

### **BUG TUSSEL WIRELESS PRESENTATION:**

Kristen Peterson was present to answer questions regarding internet service with Bug Tussle through AT&T coverage. With towers located in surrounding areas, Bug Tussle would like to be up and running in the Naples area in June 2021. Questions from residents present were answered. No action.

### **BASEMENT WALL:**

Olson signed an agreement with Monarch for a settlement of \$30,000 for damages of the basement wall during paving of the play area. Money will be deposited in the Building Account for future repairs. The south wall is bowing as well; suggestion to fix at the same time. Bidding on the wall will be advertised and Olson will collect the bids. Motion by Cole and seconded by Accola to deposit the money into the Building Account when received. Motion carried.

### **ROAD CONSTRUCTION:**

Buffalo County Highway Commissioner, Bob Platteter, Olson, and Accola accessed road conditions. Platteter made his recommendations of road work to be completed: Mill and pave Segerstrom; Chip seal Whitworth, Golf, and Deer Run; Mill west and north ends of Cole Road and let go through a frost/thaw before paving; Ditching along Moe Road; Ditching along Cole Road with culvert replacement.

Cathy Cole was present with concerns of Cole Road staging and the lack of maintenance on the road; suggesting waiting a year will result in loss of work completed. She has concerns with maintenance on roads and Cole Road is in the worst shape it has ever been in. She questioned why Cole Road's maintenance repairs were pushed back and not completed when planned. After discussion, motion by Cole to replace and repair Cole Road; with lack of a second the motion died. Cole Road is scheduled for construction in 2022.

### **DOUG TOLLEFSON SERVICE CONTRACT:**

Olson commended Tollefson on his service to the township. With other townships paying 50K-60K a year, Olson says Tollefson is working for a fair price. Having a full-time patrolperson would result in more expenses with additional equipment needed. Regular maintenance paid in 2020 was around \$32K. Tollefson was present and stated he is working for everyone in the township and is available on a call basis. Cathy Cole commented that the road maintenance is under standard and would like to see other companies have a chance at the township work. Brett Cole will reach out to companies for bids on maintenance for the upcoming contract. No action.

**PAYMENT OF BILLS:**

All bills were presented and paid.
