TOWN OF NAPLES BOARD MEETING November 17, 2025

CALL TO ORDER:

The Town of Naples Monthly Board Meeting was called to order at 6:06 p.m. by Town Chairman, Ross Kruger presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755

ROLL CALL

Board members present: Town Chairman, Ross Kruger, First Supervisor, Neil Segerstrom, Second Supervisor, Scott Smith, Town Treasurer, Pamela Hansen, and Town Clerk, Jackie Dregney.

APPROVE MINUTES FROM SEPTEMBER MEETING

Motion by Smith and seconded by Segerstrom to approve October 20 minutes. Motion carried.

VERTICAL BRIDGE CELL TOWER ZOING PROPOSAL

Curt Walter was present with Vertical Bridge presenting the Board with a proposal for a T-Mobile cell tower located at W416 US Hwy 10 off Alleman Road. This location is being proposed as the reception for connecting city residents as well as township residents was more ideal. Tower would be installed along the tree line respecting the three hundred fifty-foot setbacks. If road access is lost via the sawmill easement another road will be placed north of the existing access. If the tower is not used for 12 months it will be dismantled. This will go before the County Board at a Public Hearing for final approval. Motion by Smith and seconded by Segerstrom to support the construction of the cell tower with notation no hauling of concrete will occur until the frost is out of the ground. Motion carried.

TREE AND BRUSH TRIMMING PLAN

Kruger stated Nelson Road will be worked on removing brush and trimming trees. The right of way along that road is being encroached by private fences and residents along that road that have brush and trees overgrown will be notified to have them removed so maintenance can continue. Possible chip sealing in 2026 for Nelson Road. Discussion of other roads needing attention included Pace, Munson, and culverts on Cole.

SEGERSTROM ROAD FOLLOW UP ON STATE FUNDS

Kruger reached out to Oakridge Engineering with no response.

APPROVE 2026 BUDGET

Motion by Kruger and seconded by Smith to approve the 2026 Budget as presented.

CHAIR REPORT

Andy Schneider began siding construction on the Town Hall. Will replace steel with LP Smartside due to findings behind the siding when it was removed.

TREASURER'S REPORT

Hansen reviewed budget numbers and stated taxes will be going out in December.
