## **TOWN OF NAPLES BOARD MEETING September 11, 2023**

### **CALL TO ORDER:**

The Town of Naples Monthly Board Meeting was called to order at 6:03 p.m. by Town Chairman, Ross Kruger presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755

### **ROLL CALL**

Board members present: Town Chairman, Ross Kruger, First Supervisor, Neil Segerstrom, Second Supervisor, Scott Smith, Town Treasurer, and Pamela Hansen. Absent was Town Clerk, Jackie Dregney.

### **CITIZEN'S COMMENTS**

Karon Olson was present to get information on widening a field driveway on Dutter Road. Kruger will meet her onsite to approve the construction. She was also looking for information on future construction on Tanner Road and what the plans are.

### **BUFFALO COUNTY SHERIFF MIKE OSMOND**

Buffalo County Sheriff, Mike Osmond was present to introduce himself and update the board on statistics from the county office. He will send Kruger updates that pertain to Naples Township when they occur. UTV/ATV issues have been minimal in the county. Osmond is currently working with other municipalities on the flock camera system and explained how it works.

Motion by Smith and seconded by Segerstrom to approve the August 14 minutes. Motion carried.

### **ROAD CONSTRUCTION**

Deer Run is completed. Scott's Construction has submitted a bid for Hovey Valley for crack filling of \$10,000. Motion by Segerstrom and seconded by Smith to accept the bid from Scot's Construction for crack filling and move ahead with completion in 2023. Motion carried.

### **CHAIR REPORT**

Kruger followed up with grant writer but made no contact due to being on vacation.

### **2024 FIRE CONTRACT WITH CITY OF MONDOVI**

Contract will be brought back to next meeting for formal approval.

### **SAND STORAGE**

Discussion on sand storage unit. Cost of the storage unit as described would be more than \$60,000. Kruger will do more research on other ideas before deciding. Will table until winter and use the pile as in the past until further information is compiled. Tollefson would like to build up the current area to avoid runoff into the ditch.

### **TOWN HALL SIDING**

No action.

Final tax payments have been received. Budget update was shared. Maps of the township were shared. Road petitions from the county were discussed.
