TOWN OF NAPLES BOARD MEETING

July 11, 2022

CALL TO ORDER:

The Town of Naples Board Meeting was called to order at 6:00 p.m. by Town Chairman Dennis Olson presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755

ROLL CALL:

Board members present: Town Chairman, Dennis Olson, First Supervisor, Paul Accola, Second Supervisor, Brett Cole, Town Treasurer, Andy Goss, and Town Clerk, Lynn Smith. Also present was Heather Schultz, Bryan Wulff, Karen Olson, Cathy Cole and Sue Iverson.

APPROVE MINUTES:

Motion by Accola and seconded by Cole to approve the minutes from June 13, 2022. Motion carried.

TOWN HALL MAINTENANCE:

Chair called for bids for town hall's front door. Tom Nogle's bid was 3550.00 to remove old door, get a primed door, use same hardware, and get new threshold. Painting bid- 500.00. Ryan Gonstad bid was 3500.00 for the same. Chair offered to paint door at 15/hr. Representative from Builder's Millwork asked to get a bid. Decision tabled until that is obtained. No bids came in for hall's furnaces. Alcivia plans to look at furnace prior to making a bid.

ALLIANCE BANK ACCOUNT

Motion was made and seconded to close account once all outstanding checks have cleared. Motion carried.

FIBEROPTIC UPDATE:

TCC spoke with Town Chair. They stated they ran into rock which did delay them. Hook-ups are still hoped to be completed this Fall with entire project being completed by Jan./Feb. 2023.

TREASURER'S REPORT:

Treasurer stated all accounts are in good standing. Revenue has had no surprises. Fire dues go to Mondovi. First shared revenue will be due in July. One GPA is left.

CLERK'S REPORT:

Three extra fire signs were obtained from the county. Our voting machine is now at the hall for 8/9/2022 election. Town could use additional election workers. DOR Federal infrastructure survey was completed as due 7/11/22. Weber's inspection report for June was reviewed. A scanner was purchased for township use. Town has a new residence- Justin/Ashley Goss at W510 CR HH. Concerns re: ditch mowing were shared. Town Hall's septic tank maintenance is due- notice shared with the Chair who will contact Slaby out of Waumandee. Town's CT form has one error yet-being worked on for resolution.

PAYMENT OF BILLS

Bills were paid as presented.

OTHER BUSINESS:

Questions arose regarding citizen's input. This will be put on next month's agenda. Dennis to contact grant folks re: rules and Doug will be asked to look at Segerstrom Rd. Due to no other business, the meeting was adjourned at 6:35 p.m.
