TOWN OF NAPLES BOARD MEETING August 10, 2020

CALL TO ORDER:

Meeting was called to order at 6:00 p.m. by Town Chairman Dennis Olson presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755.

ROLL CALL:

Board members present: Town Chairman, Dennis Olson, First Supervisor, Paul Accola, Town Treasurer, Andy Goss, and Town Clerk, Jackie Dregney. Absent was Second Supervisor, Brett Cole. Residents present were Bruce Wulff and Neil Segerstrom.

PUBLIC COMMENTS:

Bruce Wulff was present to ask questions on the status of Segerstrom Road and what the plan was for repair. The road is in dire need of repair. He also inquired about Alleman Road Bridge, but was advised by Olson that information regarding the bridge comes mainly from the State.

APPROVE MINUTES:

Motion by Accola and seconded by Olson to approve the minutes from July 13, 2020. Motion carried.

FUEL CONTRACT WITH COUNTRYSIDE COOPERATIVE:

Countryside submitted a cost of fuel for the upcoming season at \$1.06 per gallon. Olson will contact Thaler Oil to get a price from them before decision is made. No action.

APPROVE CONTRACT WITH CHIMNEY ROCK APPRAISALS FOR TOWN APPRAISER:

Motion by Olson and seconded by Accola to approve Chimney Rock Appraisals for Town Appraiser for a three-year contract costing \$26,100 which includes a revaluation and two years of maintenance. The yearly cost of \$8,700 will be made in three installments of \$2,900 each. Motion carried.

ROAD CONSTRUCTION/WORK WITH TREMPEALEAU COUNTY:

Due to Buffalo County Highway Department not having a Commissioner, Olson contacted Trempealeau County and they have agreed to do road construction starting the third week in September. Doug will put culverts in and do final grade compacting. Motion by Accola and seconded by Olson to approve the road construction by Trempealeau County. Motion carried.

APPROVE ELECTION MACHINE PURCHASE:

After discussion on two styles of voting equipment; motion by Olson and seconded by Accola to purchase a tabulator machine and a touch-screen machine for elections. Dregney will submit the bill for the tabulator to the Routes to Recovery Grant for possible payment due to COVID-19. Motion carried.

APPROVE PICNIC LICENSE FOR WI HORSE PULLERS ASSOCIATION FOR AUGUST 28-AUGUST 30, 2020 AT DOUBLE H ARENA:

Motion by Accola and seconded by Olson to approve a picnic license for WI Horse Pullers for dates listed. Motion carried.

APPROVE OPERATOR'S LICENSE FOR TRAVIS SOPPA:

Motion by Olson and seconded by Accola to approve an operator's license for Travis Soppa. Motion carried.

DISCUSS OTHER BUSINESS:

No other business.

PAYMENT OF BILLS:

All bills were presented and paid.
