## **TOWN OF NAPLES BOARD MEETING September 16, 2024**

### **CALL TO ORDER:**

The Town of Naples Monthly Board Meeting was called to order at 6:05 p.m. by Town Chairman, Ross Kruger presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755

### **ROLL CALL**

Board members present: Town Chairman, Ross Kruger, and First Supervisor, Neil Segerstrom, Second Supervisor, Scott Smith, Town Treasurer, Pamela Hansen, and Town Clerk, Jackie Dregney.

### **CITIZEN'S COMMENTS**

### **APPROVE MINUTES FROM AUGUST MEETING**

Motion by Smtih and seconded by Segerstrom to approve the August 12 minutes. Motion carried.

### **IVERSON PROPERTY PROPOSED ROAD**

Scott and Mark Iverson were present to get the Board's "good faith intention" for the driveway they are intending to make into a road that the town has agreed to take over and maintain once it is to current standards. They submitted a Certified Survey Map, along with an affidavit. There will be no transfer of land ownership until the road is complete and all standards are met. Current landowner will remove trees and complete the road at their own expense. Motion by Smith and seconded by Segerstrom on a contingent verbal approval of accepting the road once it is complete and it complies with all specifications of a township road. Motion carried. A spring 2025 completion date is planned.

### **ROAD CERTIFICATION MAP FOR WISCONSIN INFORMATION SYSTEM FOR LOCAL ROADS (WISLR)**

The WISR Road Map was reviewed and signed by Kruger.

### **LRIP/ARIP UPDATE**

Kruger shared an update on the LRIP and ARIP programs. Town will continue to work with Trempealeau County as a joint application on the ARIP. Bids for Segerstrom Road will be open when the detailed plan is received. Kruger will advise when to start advertising for bids.

### **ROAD SIGNS**

Tollefson created a list of signs and their condition. Dregney will get a cost of 9" road signs. Stop signs needed on Cole Road. Interest in Cole Road sign by a resident. If an old sign is replaced, they may have one otherwise if an order is placed for new signs the resident may purchase one at that time.

### **CHAIR REPORT**

Kruger discussed expenses incurred by Western Dairyland's Head Start program. The quarterly water testing by a certified DNR operator is no longer needed as the school does not serve 25 people. This previously costed the township over two thousand dollars a year.

### **TREASURER'S REPORT**

Hansen shared information regarding road petitions. The county has a new Highway Commissioner who could not find the petition list. Cole Road was double chip sealed with no warning from the county. Will push county to get their bills out in a timely manner as January bills have not been received yet.

**PAYMENT OF BILLS PRESENTED**

Bills were paid as presented.
