TOWN OF NAPLES BOARD MEETING

June 13, 2022

CALL TO ORDER:

The Town of Naples Board Meeting was called to order at 6:00 p.m. by Town Chairman Dennis Olson presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755

ROLL CALL:

APPROVE MINUTES:

Motion by Accola and seconded by Cole to approve the minutes from May 9, 2022. Motion carried.

APPOINTMENT OF NEW TOWN CLERK:

Motion by Cole and seconded by Accola to appoint Lynn Smith as new Town Clerk. Motion carried. Oath had been given by Jackie Dregney earlier.

TOWN HALL MAINTENANCE:

Chair called two persons for additional bids for town hall's front door. One did not respond. Tom Nogle is working on a bid. Chair will try to obtain another bid. The town hall's two furnaces were discussed as 30 years old and some parts can no longer be obtained. Motion made by Cole and seconded by Accola to have Chair obtain furnace bids for one furnace.

BUFFALO COUNTY ROADWORK:

Chair was notified by County that Ward culvert arrived. Chair and Doug will discuss how to get it to Naples. Due to high cost of gas the mowing of ditches will be made with 2 passes vs. the former 3. Cole stated Cole road has washed with recent rainfall. Doug to look into grating/adding gravel.

FIBEROPTIC UPDATE:

TCC has talked with Town Chair. They stated they are on schedule. Doing North of Hwy 10 currently and then South of Hwy 10. Feel they will be all completed, including all homes by Jan./Feb. 2023.

APPROVAL OF BEER, LIQUOR and OPERATOR LICENSES:
