TOWN OF NAPLES BOARD MEETING

MARCH 9, 2020

CALL TO ORDER:

Meeting was called to order at 6:01 p.m. by Town Chairman Dennis Olson presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755.

ROLL CALL:

Board members present: Town Chairman, Dennis Olson, First Supervisor, Paul Accola, Second Supervisor, Brett Cole, Town Treasurer, Andy Goss, and Town Clerk, Jackie Dregney. Also present were Bruce Wulff, Barb Alleman, Neil Segerstrom, Lloyd Mc Quistian, and Doug Tollefson.

PUBLIC COMMENTS:

There were no public comments.

APPROVE MINUTES:

Motion by Cole and seconded by Accola to approve the minutes from February 10, 2020. Motion carried.

DISCUSS/ACTION ON LOWERING WEIGHT LIMIT OR CLOSING ALLEMAN BRIDGE:

Discussion by board and citizens present on whether the Alleman Bridge should be closed or reevaluate the inspection to have the weight limit lowered in order to keep it open. Barb Alleman voiced concern of heavy vehicles using the bridge and that would continue even with stricter restrictions. Olson has been in contact with the County regarding the issue and feels for public safety it should be closed. Wulff stated removing some asphalt to inspect the beams and condition underneath. Beams are already weak in the middle of the span. Concerns were brought up of exposing the Township to liability if the bridge were to fail. They are leaning toward closing the bridge; Olson will speak to the County regarding the safety and strength of the bridge. Closing the bridge would bring inconvenience to that area, but the safety of the public is the main concern. Tabled until next meeting after discussion with inspector one last time. No action.

DISCUSS/ACTION ON NEW TOWN WEBSITE:

Motion by Accola and seconded by Cole to approve payment for the new website. Board discussed the new website and what would be available on it. Cole said it was up and running and he is able to add/change information as needed. Motion carried.

DISCUSS/ACTION ON ROAD LOANS:

Discussion on loans for road construction will be discussed further at the annual meeting on April 21, 2020.
