#### **CITIZEN'S COMMENTS**

Heather Schultz, Wulff Road, was present to voice concerns with the timeframe of snowplowing being completed. She stated one pass is made and multiple hours go by before the other pass is complete. Doug explained the route process and using the most economical way of not having to travel multiple trips to reload sand.

#### **APPROVE MINUTES FROM JANUARY 9 SPECIAL MEETING**

### **INTERSECTION OF ALLEMAN/YOUTH ROADS**

Olson visited the blind area in question. The county has recommended placing a T-sign nearby for an estimated cost of \$200. Motion by Cole and seconded by Accola to place the sign near Tanner Road. Motion carried.

### **ELECTIONS COMMISSION SECURITY SUBGRANT**

Dregney described options for using the \$1,200 grant received by the Wisconsin Elections Commission for added security and IT support. Plans to use the money for a computer as one town computer is from 2008 with no support. Motion by Cole and seconded by Accola to allow Dregney to purchase a new computer not exceeding the grant amount. Motion carried.

## FIBEROPTICS INSTALLATION UPDATE

Homes are being connected mostly north of Highway 10. Currently started connecting homes on the south side. Every household should be connected by the end of March early April. All will be completed by the end of May. Residents not residing in their homes during the winter months will be revisited.

## **BUFFALO COUNTY RECYCLE CENTER TENANT FEES**

Buffalo County and the City of Mondovi have come to an agreement for tenant expenses. The town will no longer by obligated to pay tenant fees to the city. The outstanding fee from 2022 will be paid.
