## TOWN OF NAPLES BOARD MEETING

May 09, 2022

### **CALL TO ORDER:**

The Town of Naples Board Meeting was called to order at 6:05 p.m. by Town Chairman Dennis Olson presiding over the meeting at Naples Town Hall, S283 County Road BB, Mondovi, WI 54755. It was announced that there would no longer be citizen comments due to past history of meeting interruptions by citizens present.

### **ROLL CALL:**

Board members present: Town Chairman, Dennis Olson, First Supervisor, Paul Accola, Second Supervisor, Brett Cole, Town Treasurer, Andy Goss, and Town Clerk, Jackie Dregney. Also present was Doug Tollefson, Lynn Smith, Bryan Wulff, Bruce Wulff, Cathy Cole, and Neil Segerstrom.

### **APPROVE MINUTES:**

Motion by Accola and seconded by Olson to approve the minutes from April 11, 2022. Motion carried.

### **RETRACTION OF COLE VOTE:**

Motion by Cole to retract his vote from the April 11 meeting, approving of Oakridge Engineering to submit grant applications for Whitworth, Wulff, and Dutter Roads, omitting Golf; for \$1000 each. No second. Motion died.

### **TOWN HALL MAINTANENCE:**

Bids were discussed. Vinyl siding-over \$25,500; Smart siding-\$28,000; 3 doors- \$13,500; 1 door and painting of two-\$3600.00. Cole requested additional quotes on doors with emphasis on main door. Will be added to next month's agenda. No action.

### **BUFFALO COUNTY ROADWORK:**

Naples owes Buffalo co. \$91,937 for Alleman bridge and 2 culverts on Cole Road. This payment is due. Motion by Cole and seconded by Accola. Motion passed. Additional \$48,528 is due to the county at years-end for Ward Road culvert.

### **COLE ROAD**

Motion by Olson and seconded by Accola to remove Cole Road East end paving from the 2022 construction due to other financial obligations: \$91,000 due to co. now, owing TCC \$165,000, and Ward Rd. culvert \$45,000 all by years-end. Citizen interrupted at 6:20. Olson requested citizen to cease speaking. This was refused. Olson requested citizen to leave the premises. This was refused. Buffalo County Sheriff's Department was called. A Buffalo co. Sheriff's deputy, with assistance from a Mondovi Police officer escorted the citizen off of the premises. Meeting was restored, motion carried.

### **MFL RESOLUTION**

MFL Resolution R-22-05-01 to have the State crack down on MFL was passed with motion by Cole and second by Accola.

### **PAYMENT OF BILLS**

Bills were paid as presented.

### **OTHER BUSINESS:**

Having no other business, the meeting was adjourned at 6:51 p.m.
